Nomination Process

#	Step	Description
1	Nomination Form	Nominees to complete the Board or CAC nomination form (see Annex A).
2	Submit Form	Nominees to submit form to the Project Office in person or in mail or online.
3	Police Clearance	Board nominees submit a police clearance to the Project Office.
4	Receipt	The Project Office confirms receipt.

¹Politically affiliated person includes Members of the Provincial Assembly, Ward Committee, Constituency Development Committee, Tina Core Land Owning Company (TCLC), the Project Office and THL.

Candidates can nominate for both a position on the Board and the CAC. Should a candidate be successful in both positions, they will be selected as a Board member and will forfeit their CAC position.
